## .... EOC Meeting Includes Amateur Radio ...

A planning meeting was held on Friday, July 9th at the Emergency Operations Center for the purpose of discussing the present and future roles of the agency and the various community organizations that provide support and assistance to the EOC.

The meeting was chaired by current EMA Director Rick Alatorre with representatives from the American Red Cross, Central Stark Chapter, Civil Air Patrol, Tri-County Alert, Stark County Building Department, United Way Services of Stark Co. and the Amateur Radio Emergency Service. Several amateur's were present including the President of the Alliance ARC and members of the Canton ARC. Representing the ARES was Assistant EC Terry Russ - N8ATZ.

Rick opened the meeting by defining the role of the EOC in both small and large scale disasters and briefly discussed the roles that each community agency would play in the event of such disasters. He showed the meeting participants the current layout of the EOC which was prepared in 1999. It was interesting to note that Amateur Radio was not included on the list.

Rick is proposing a new layout of the EOC responsibilities which now includes a more defined role of the Amateur Radio

Service. As part of this effort, Rick is updating each agencies file to include the exact role and responsibility each agency would play including the ARES.

Rick is also proposing adding a new component to county emergency operations called VOAD which is Voluntary Organizations Active in Disasters. This umbrella organization helps bring together community groups during disaster situations to maximize resources and manpower. What role Amateur Radio would play is yet to be determined.

Rick concluded the meeting by reaffirming his commitment to work together with all community organizations to make a stronger EOC office that is fully prepared to handle all emergencies that may happen here in Stark County. A follow up meeting is being planned for sometime in August or September.

## .. The 2003 Simulated Emergency Test Results ..

The July issue of QST Magazine has the results of the 2003 Simulated Emergency Test (SET) and once again the Ohio Section has made the top 10 list placing 2nd overall with 3,559 points and 7th in Section/Local Nets with 610 points.

Congratulations to our Stark County amateurs as we placed 12th in the State with 94 points. While this is lower than our past two years scoring, we continue to show a strong ARES participation.

While not really a point generating contest, the SET is an important indicator of each local ARES group's commitment to community service. The basic theme of the SET is to determine the strengths and weaknesses of each ARES groups program as it relates to providing emergency communications. October 2 and 3 is the main weekend for this years SET. This is also the weekend of the 2004 Akron Marathon and we hope to combine this large scale public service event with this years SET.

## John Kraus, W8JK Silent Key

John Kraus, W8JK died at the age of 94 on July 20. Kraus, a creative thinker, made several significant contributions to the antenna world in general and Ham Radio in particular. A professor at Ohio State University, he also contributed significantly to radio astronomy.

Prior to his invention of the W8JK antenna in the mid 30s, it was commonly thought that to get more gain from an antenna it had to be made bigger and bigger. Kraus realized that by placing elements closer together and forcing a phase shift that gain could be realized from an antenna much smaller than conventional arrays at the time. This was not generally accepted thinking among the professional EE community at the time and he had difficulty publishing professionally, so he published it in Radio magazine, a forerunner to the present CQ magazine. The W8JK antenna was a popular antenna for many years, in many forms and derivatives, including the ZL special and W7EL's field day special.

Kraus invented the helix antenna after seeing the then new Traveling Wave Tube (TWT) amplifier demonstrated at an OSU seminar. The TWT uses a tightly wound helix to amplify by traveling waves of electrons. Kraus asked the lecturer if the helix radiated. The lecturer replied no, that the circumference was too small. Kraus realized that the larger helix might make an effective circularly polarized antenna. Kraus went home that evening and wound one with a larger circumference and the helix antenna was born. The helix antenna has been a main stay of the space community since its inception.

Kraus also invented the corner reflector antenna after realizing that the method of images could be implemented physically. It was a widely used antenna for UHF TV and point to point microwave transmission for many years.

Kraus also invented the Big Ear radio telescope at OSU after realizing that electrically steering an antenna was far simpler than moving giant dishes.

Kraus was the author of "Antennas", an excellent textbook on antennas. It is still in print, in the second edition, more than 50 years after its initial publication. He will be missed.

## ASCII DEVELOPER DIES

Bob Bemer, a computer pioneer who published warnings on the Y2K problem in the early 1970's and helped invent a widely used coding system, has died, following a battle with cancer.

Bemer was not a radio amateur, but played a role in how the world's computers operate and indirectly, how hams communicate today.

His career began in 1949, working at companies, such as Rand, IBM and Honeywell. He also helped devise the ASCII coding system, used to represent letters, numbers and other characters, in the data world and contributed the escape key and back slash to the computer language.

Bemer published warnings of the Y2K computer problem in 1971 and 1979. He made several appearances to discuss the issue in the years leading up to the millennium. He died Tuesday, June 22, 2004 at his home, some 120 miles west of Dallas, Texas, at age 84.

## VANITY CALL SIGNS PRICE INCREASE

The FCC regulatory fee to obtain an Amateur Radio vanity call sign will rise from \$ 16.30 to \$ 20.80 on Friday August 6, 2004.

The FCC announced the new fee in a Report and Order (R&O) in MP Docket 04-73, which will become effective 30 days after publication in the Federal Register.

## THE FCC TURNS 70

(From QRM Newsletter Volume 28, number 2 August issue)

On July 1, 2004 the Federal Communications Commission (FCC) turned 70 years old. That was the effective date of the Communications Act of 1934, passed by Congress on June 19, 1934, in a document consisting of 333 pages. The FCC replaces the Federal Radio Commission, which was established seven years earlier.

The FCC is directly responsible to congress with regulating interstate and international communications by radio, television, wire, satellite and cable. Jurisdiction covers all 50 states, the district of Columbia and US possessions.

The FCC has five members, all appointed by the president and confirmed by the Senate and six bureaus. Previously, the Commission had seven members and three divisions. According to the FCC, the term 'amateur station' means a radio station operated by a duly authorized person interested in radio technique solely with a personal aim and without pecuniary interest.

**5X, UGANDA.** Jay, K4ZLE, will once again return here and be active (as time permits while there) as **5X2A** from **August 3-21st**. Some effort will be made to operate on the lower bands this year, mostly CW. Activity is also planned for PSK31. QSL direct via K4ZLE.

**A35, TONGA** (Update/Change In Plans/Rotuma - Possibly Later). Aisea, 3D2AA, informs OPDX that Christian, 3D2EA, has changed his plans and is now active from **Tonga** instead of Rotuma. Christian was first heard active as **A35EA**, but now it seems he is signing **A35DX**. He is expected to be active **until July 29th**. Activity will be on 40/17 meters and mainly on 20 meters. Christian is still hoping that when he gets back from Tonga he shall reconsider his Rotuma trip. QSL via 3D2EA.

**AFRICA TRIPLE HOP DXPELITION 2004.** Dave/ K4SV and Neil/VA7DX return to Africa **July 28th** and will be active from three DX locations through **August 17th**. Dave and Neil will operate from **Lesotho, July 29th to August 6th, Swaziland, August 7-11th** and **Mozambique, August 12-17th**. Activity will be on CW, SSB, RTTY and other digital modes, with operations planned for 160-10 meters; subject to daily propagation conditions, with focus on the low bands nightly. Special effort will be made to work the general portion of the bands. Equipment has been provided by ZS6WB for meteor scatter and EME operation on 2m and 6m using FSK441 and JT65. Patience will be required because neither operator has much experience in either mode. Verticals will be used on 160 to 30 meters with 4 element A4S and WARC beams at 75 feet for the higher bands.

Towers, antennas, logistical support, licensing and all in-country arrangements have been handled by African DX Safaris - ZS6WPX. They suggest that anyone needing these countries get your antennas ready to go now. Last year's call signs will be reactivated with Dave using **7P8DA, 3DA0SV** and **C91DA**. Neil will use **7P8NK, 3DA0WC** and **C91NK**. Information on how to QSL and online logs will be available at: <http://www.k4sv.com> Logs will be uploaded daily and will be updated with the date of any QSL requests received and sent. QSL Manager for the entire operation will be: Stephen K4YL, PO Box 183, Flat Rock, NC 28731-0183 USA.

**P40, ARUBA.** Ken/K6TA and Kay/K6KO will be active from here as **P40TA** and **P40K**, respectively, from **November 30th to December 21st**. Both operators plan to be active as **P40K** in the **ARRL 10 Meter Contest (December 11-12th)** as a Multi-Single/High-Power entry. Also, look for **P40TA** in the **ARRL 160m Contest**. QSL both call signs via WM6A.

- Mac, W3HC, informs OPDX that he is now the QSL Manager for **9A6DR**. He also mentions that the new cards are being printed for **PS2T** at this time.

**T6, AFGHANISTAN.** Henry, F6EAY, is currently assigned in Kabul, Afghanistan, and is active using the call sign **T6RF** only on PSK31. Henry states, "The propagation is not very good and the signals are weak." QSL via his manager, Jean Pierre, F6ITD.

**XU7, CAMBODIA.** Jaak, ES1FB, will once again be active as **XU7ACE** starting around **October 15th and end November 5th**. QSL via ES1FB.

**YV0, AVES ISLAND.** The official YV0 DXpedition announcement was finally released this past week by the RCV. The press release states:

"The Radio Club Venezolano (RCV) is celebrating the 70th anniversary and would hereby announce an expedition to Aves Island - one of the top ten most wanted DXCC entities.

Aves Island (**NA-020**) is located at 15 40' 33" North 63 36' 27" West (FK85eq) which is around 600 kilometres north of mainland Venezuela. The island is about 580 meters long and 150 meters wide. The highest point on the island is only about 3 meters above sea level. Aves Island was claimed by Venezuela in 1865.

On August 23, 1972, the island was declared a wildlife sanctuary. In 1978 the Venezuelan Navy established a garrison in Aves called the Simon Bolivar = Scientific-Military Base. Now a new garrison has been installed this month, and this expedition will be there at the time of its inauguration. Last DXpedition to YV0 was in 1994.

**Dates:** From **July 28th until August 8th.** (on-the-air period depends on voyage to Aves)

**Operators:** K4UEE, K6MYC, OH2BH, OH0XX - as invited guest operators. The host group is YV1AVO, YV1DIG, YV4BOU, YV5AMH, YV5IVB, YV5JBI, YV5KM, YV5KXE, YV5OIE and YV6BTF. Also YY5FRD will be part of the crew.

**Antennas:** Sigma & SVDA vertical monoband antennas for HF provided by FORCE 12, the leading edge antennas for many successful DXpeditions and contest operations. On VHF M2 2x 41 ft. boomers on 6m and a 15.7 dbd yagi for 2m will be used. Crossed yagis for UHF and VHF will be used in satellite operation.

**Modes:** SSB, CW, RTTY, PSK, SSTV, FM and some other digital, many modes for the 1st time from YV0.

**Bands:** 75cms thru 160m including WARC's and satellite.

EME: Moon bounce operation for the 1st time from YV0.
