The July issue of QST Magazine has posted the results of the 2004 Simulated Emergency Test (SET) and once again the Ohio Section has made the top ten list placing 5th overall with 2,157 points and 4th in Section/Local Nets with 907 points.

The SET is a nationwide exercise in emergency communications. Both the Amateur Radio Emergency Service (ARES) and the National Traffic System (NTS) are involved. SET gives amateur radio operators the chance to focus on their emergency communications capability and it's interaction with served agencies while testing operator skills and emergency equipment.

October 1 and 2, 2005 is the main weekend for this years SET exercise and your local coordinators are reviewing ideas for this years participation.

POLAR EXPRESS TRAIN RIDE

The information available at this time is that there are scheduled Polar Express Train Rides at the Dennison, Ohio Depot on the following dates: December 1,2,3 and December 8,9,10, and December 15,16,17. There is 1 ride on Thursday and Friday and 2 Rides on Saturdays.

There is an opportunity to volunteer help with the train rides. Positions open are Mr. and Mrs. Claus, Car Host, Story Reader, Assistant, Elves, and help parking automobiles. There are 10 train cars with approximately 6 volunteers per car. The train ride lasts for approximately 1 1/2 hours. It is required that a volunteer attends a training session during a scheduled weekday evening. The training sessions are in the planning stages and generally occur in September, October, and maybe early November.

The train ride leaves Dennison, Ohio to the North Pole and the Polar Express Book is read by the storyteller. A cup of hot chocolate and a cookie is given to each passenger (and volunteer). At the North Pole are elves, Santa, etc. On the return trip, Christmas carols are sung and Santa visits each child and gives a bell as a gift.

NOTE: Quite often there is no seating for the volunteers since many of the rides are sold out. Some seats rarely become available due to cancellations.

ARLB018 FCC proposes dropping Morse code requirement entirely

The FCC has proposed dropping the 5 WPM Morse code element as a requirement to obtain an Amateur Radio license of any class. The Commission included the recommendation in a July 19 Notice of Proposed Rule Making (NPRM) in WT Docket 05-235, but it declined to go along with any other proposed changes to Amateur Service licensing rules or operating privileges. Changes to Part 97 that the FCC proposed in the NPRM would not become final until the Commission gathers additional public comments, formally adopts any new rules and concludes the proceeding with a Report and Order specifying the changes and an effective date. That's not likely to happen for several months.

"Based upon the petitions and comments, we propose to amend our amateur service rules to eliminate the requirement that individuals pass a telegraphy examination in order to qualify for any amateur radio operator license," the FCC said. The NPRM consolidated 18 petitions for rule making from the amateur community—including one from the ARRL—that had proposed a wide range of additional changes to the amateur rules. The FCC said the various petitions had attracted 6200 comments from the amateur community, which soon will have the opportunity to comment again—this time on the FCC's NPRM.

The Commission said it believes dropping the 5 WPM Morse examination would encourage more people to become Amateur Radio operators and would eliminate a requirement that's "now unnecessary" and may discourage current licensees from advancing their skills. It also said the change would "promote more efficient use" of amateur spectrum.

To support dropping the code requirement, the FCC cited changes in Article 25 of the international Radio Regulations adopted at World Radiocommunication Conference 2003. WRC-03 deleted the Morse testing requirement for amateur applicants seeking HF privileges and left it up to individual countries to determine whether or not they want to mandate Morse testing. Several countries already have dropped their Morse requirements for HF access.

ARRL CEO David Sumner, K1ZZ, said he was not surprised to see the FCC propose scrapping the Morse requirement altogether, although the League had called for retaining the 5 WPM requirement only for

Amateur Extra class applicants. Sumner expressed dismay, however, that the FCC turned away proposals from the League and other petitioners to create a new entry-level Amateur Radio license class.

"We're disappointed that the Commission prefers to deny an opportunity to give Amateur Radio the restructuring it needs for the 21st century," he said. "It appears that the Commission is taking the easy road, but the easy road is seldom the right road."

Sumner said ARRL officials and the Board of Directors will closely study the 30-page NPRM and comment further once they've had an opportunity to consider the Commission's stated rationales for its proposals.

In 2004, the League called on the FCC to create a new entry-level license, reduce the number of actual license classes to three and drop the Morse code testing requirement for all classes except for Amateur Extra. Among other recommendations, the League asked the FCC to automatically upgrade Technician licensees to General and Advanced licensees to Amateur Extra. In this week's NPRM, the FCC said it was not persuaded such automatic upgrades were in the public interest.

The FCC said it did not believe a new entry-level license class was warranted because current Novice and Tech Plus licensees will easily be able upgrade to General once the code requirement goes away. The Commission also said its "Phone Band Expansion" (or "Omnibus") NPRM in WT Docket 04-140 already addresses some of the other issues petitioners raised.

A 60-day period for the public to comment on the NPRM in WT 05-235 will begin once the notice appears in the Federal Register. Reply comments will be due within 75 days.

I had not planned to send an additional newsletter so soon; however, "breaking news" (I'm preparing for a TV news job) and several requests to re-send the information on writing about BPL and US House Resolution related to it suggest this is the thing to do. If you've already written about H.R. 230, please read down to the information on it.

BAIZE APPOINTED STATE LEGISLATIVE ACTION COORDINATOR

Just as soon as I booted up my computer today I received a note from Dick Mondro, Vice Director and Division Legislative Action Chairman, that Gregory Baize, KG4VJC has accepted appointment as the State Legislative Action Coordinator, Kentucky. Greg is highly qualified for this post. He will report to Division LAC Mondro.

With the Great Lakes Division leadership positions in the critically-important ARRL Grassroots Lobbying project filled, Dick, Gregory (Kentucky SLAC), Jim (Ohio SLAC), Val (Michigan SLAC) and I will hold a telephone conference Saturday, July 2 to begin the major effort of developing the program structure in each of the three states in our Division.

HQ E-MAIL SERVER WILL BE DOWN FOR UPDATING

The E-mail server at ARRL Headquarters will be off line from July 6 to 7. Anew software will be installed. This is an additional move directed by the Board to improve incrementally the HQ IT system.

AMATEUR RADIO RESTRUCTURING

In answer to requests for the status of the pending action on this by the FCC: It is my understanding that the Commissions once again is dragging its feet and that we probably have a 50:50 chance of seeing meaningful action on this proposal until near the end of this year or even into next year.

LETTER AND INSTRUCTIONS FOR PROMOTING US H.R. 230

I received a "bunch" (technical term) of requests to resend the information and letter concerning H.R. 230. This US House of Representatives resolution would "request" the FCC to perform a thorough review of its approval of BPL. Why is it important to help pass this resolution? This is quite simple. The house originates the Federal budget. Having he House asks he FCC to do a critical review is much like having parents (who control their kids' allowances) ask the kids to help with something around the home). The request is rather like a grossly understated command!

Here is the information I sent in May 30:

IF YOU HAVE NOT YET SENT A MESSAGE TO YOUR CONGRESSMAN VIA OUR LOBBYIST AND COPIED ME, PLEASE DO THIS RIGHT AWAY.

Many of you may have sent these messages from the Grassroots Lobbying Booth in the ARRL EXPO area at the Hamvention(c). If you did this and have received a copy of the message by E-mail, you will not need to send another message. However, if you did not provide your name, address, call sign, etc. to the workers at this Grassroots Booth, please do it now. Congressman Michael Ross, WD5DVR

(Ark.) has gone out on a limb in large part for ARRL. Please do not let him down by failing to support Resolution 230.

WRITE YOUR US REPRESENTATIVE TO CO-SPONSOR HOUSE RESOLUTION 230

Your urgent help is requested on this one.

From the ARRL web site: US "Representative Rep Michael Ross, WD5DVR, of Arkansas, has introduced a resolution in the US House of Representatives calling on the FCC to "conduct a full and complete analysis" of radio interference from broadband over power line (BPL). The resolution, House of Representatives Resolution 230, says the Commission should comprehensively evaluate BPL's interference potential incorporating "extensive public review and comment," and—in light of that analysis—to "reconsider and review" it's new BPL rules. If approved by the full House, the non-binding resolution, introduced April 21, would express the requests as "the sense of the House of Representatives." The FCC adopted rules to govern so-called Access BPL last October 14 in ET Docket 04-37."

OK, so what does this do to my ham friend down the street and to me? It means that we all — and many more as well — should send an E-mail to our own US House member (this is, to the House member who currently represents the House District in which each of us live). In this letter, we should ask these House members to co-sponsor House Resolution 230. This Resolution, if passed, would "ask" the FCC to review and reconsider the regulations it approved for BPL, last year.

SPECIAL NOTE: Do NOT send the letter directly to your congressman. Instead, please send it to Zach DeWaters at. Zach is an executive for the ARRL account with Chwatco, our retained lobbying firm in Washington, DC. Mr. DeWaters will put your letter into a packet of the other letters they receive for your congressman/woman and will hand-deliver the letters to the respective congressmen/women.

Because of this, address the following letter to your congressman/woman, insert the entire letter (with address, etc.) into the body of an E-mail and send the E-mail to: zach.dewaters@chwatco.com. Please copy your E-mail to me also at k8je@arrl.org. Incidentally, be certain you place an "s" in Zach's last name in his E-mail address.

As a federally licensed Amateur Radio operator in your district and also a member of ARRL — the national association for Amateur Radio, I ask you to support House Resolution 230. This resolution urges the Federal Communications Commission (FCC) to conduct a comprehensive evaluation of the potential of "broadband over power line;" (BPL) systems to interfere with public safety and other licensed radio services.

BPL utilizes electric power lines to serve as the conductors of the broadband signals. Unfortunately, because the power lines are not shielded, they also act as antennas and radiate the signals +into the air. These radiated signals will interfere with radio receivers tuned to the same frequency range. BPL has only been deployed to a very limited extent, but Amateur Radio already is experiencing severe BPL interference that the FCC has been unable or unwilling to correct. Unlike BPL, other methods of providing broadband Internet services to consumers, such as cable, DSL, wireless and Fiber to the Home, do not pollute the radio spectrum.

Last October 14, the FCC ignored the evidence that BPL systems will cause widespread interference and adopted rules for BPL deployment that provide inadequate protection to radio communication by First Responders and others who need reliable radio communication to ensure our security. The FCC needs to do what it should have done in the first place: fairly and carefully review this evidence and adopt rules that will keep interference from BPL within reasonable bounds.

Because we need no infrastructure in order to communicate, the Amateur Radio Service is the only 100-percent fail-safe emergency communication capability in the world. Interference from BPL emissions will significantly disrupt this capability. Please cosponsor H. Res. 230 as soon as possible to express your concern over the interference potential of BPL to Amateur Radio operators and to public safety licensees.

7O, YEMEN. Early last week, Vladimir, UA4WHX, informed OPDX that he is currently in Sana'a, Yemen. He stated that he has "met a number of people responsible for issuing licenses and the Spectrum Management of the Yemen Telecom, as well as two deputy ministers of the Ministry of Telecommunications and Information Technology. Vladimir also states the following:

1. Not a single amateur radio license has ever been issued in Yemen in the past 20 years. He mentions, "For those interested in the authenticity of the fact I can probably provide a written statement of the ministry confirming the fact."
2. Amateur radio has never been legalized in Yemen. "PERIOD" No legal base, no exceptions so far, but the ministry is sincerely interested in promoting the hobby. They know about it and do plan to pass laws for it as soon as possible.
3. When King Hussein of Jordan was in Yemen, he requested a license which he did not get....
4. The ministry has tried to authorize amateur radio activity in Yemen a few times, but the attempts have always got stuck at the Ministry of Interior offices being higher or lower.
