The contest exchange is fairly substantial and involves more than the usual five-nine signal report and your location. To qualify as a complete contact operators must exchange a serial number, category, callsign, check number and ARRL Section. The exchange is one of the longest in Amateur Radio contesting and has it's roots in the early 1930's when actual messages were sent as part of the competition. This makes for some good fun and great practice for emergency communications and messaging handling.

The CW Sweepstakes will be held the weekend of November 7th with Phone on the weekend of November 21st. Complete details are included in the November

... ARRL EC Course Update ...



The ARRL Continuing Education Program still offers the Level 1 Emergency Communications training course to prepare radio amateurs to properly serve our communities in time of emergency when other communications systems fail.

The structure was changed earlier this year when it was decided to discontinue both the Level 2 and 3 Certifications until such time when a new course was developed.

Since then a lot has been going on at League headquarters developing a brand new ECom Certification that is now slated to be called the new Advanced Emergency Communications Course. The time table for release has now been tentatively set sometime prior to the end of this year with classes to begin the first of 2010. It will include parts of the old Level 2 and 3 courses with a lot of newly developed material that will keep it in line with similar material developed for the Department of Homeland Security. As soon as I hear of it's release, I'll let you know.

Give Your Generator Some Space

The National Institute of Standards and Technology (NIST), the same folks that bring you WWV, publish a monthly newsletter called NIST Tech Beat. Here's an item from the 10/6/09 issue of NIST Tech Beat that will be of interest to radio amateurs:

To subdue the steaming heat of hurricanes or to thaw out during a blizzard, gasoline-powered, portable generators are a lifeline during weather emergencies when homes are cut off without electricity. But these generators emit poisonous carbon monoxide—a single generator can produce a hundred times more of the colorless, odorless gas than a modern car's exhaust. New research from the National Institute of Standards and Technology (NIST) shows that to prevent potentially dangerous levels of carbon monoxide, users may need to keep generators farther from the house than previously believed—perhaps as much as 25 feet.

Up to half of the incidents of non-fatal carbon monoxide (CO) poisoning reported in the 2004 and 2005 hurricane seasons involved generators run within 7 feet of the home, according to the U.S. Centers for Disease Control and Prevention (CDC).

Carbon monoxide can enter a house through a number of airflow paths, such as a door or window left open to accommodate the extension cord that brings power from the generator into the house. While some guidance recommends 10 feet from open windows as a safe operating distance, NIST researcher Steven Emmerich says the "safe" operating distance depends on the house, the weather conditions and the unit. A generator's carbon monoxide output is usually higher than an automobile's, he says, because most generators do not have the sophisticated emission controls that cars do.

"People need to be aware that generators are potentially deadly and they need to educate themselves on proper

use," Emmerich says. With funding from CDC, NIST researchers are gathering reliable data to support future CDC guidance.

NIST building researchers simulated multiple scenarios of a portable generator operating outside of a one-story house, using both a test structure and two different computer models—the NIST-developed CONTAM indoor air quality model and a computational fluid dynamics model.

The simulations included factors that could be controlled by humans, such as generator location, exhaust direction and window-opening size, and environmental factors such as wind, temperature and house dimensions. In the simulations the generator was placed at various distances from the house and tested under different weather conditions.

"We found that for the house modeled in this study," researcher Leon Wang says, "a generator position 15 feet away from open windows was not far enough to prevent carbon monoxide entry into the house."

Winds perpendicular to the open window resulted in more carbon monoxide entry than winds at an angle, and lower wind speeds generally allowed more carbon monoxide in the house. "Slow, stagnant wind seems to be the worst case because it leads to the carbon monoxide lingering by the windows," Wang explains. Researchers determined that placing the generator outside of the airflow recirculation regions near the open windows reduced carbon monoxide entry.

In the next phase of the study NIST will model a two-story house that researchers believe will interact with the wind differently. NIST researchers also have worked with the Consumer Product Safety Commission on related work. (See: "NIST to Study Hazards of Portable Gasoline-Powered Generators," NIST Tech Beat, March 5, 2008.)

+++ ARRL to FCC: 'tain't so McGee +++

(Following from "Weaver's Words" ARRL Great Lakes Division Director Jim Weaver; K8JE)

In a filing with the FCC, the IBEC corporation provided technical data showing that the general electrical noise floor in the US has risen considerably. The point of the submission was that any ambient noise added by BPL and similar systems was relatively negligible — justifying radiation from BPL. ARRL recently filed comments that strongly rebut the IBEC argument.

Studies done by ARRL's Ed Hare, WIRFI, totally demonstrated the incompetence of the investigative approach used by IBEC. Using more sophisticated and accepted methodology, the ARRL study clearly supports the continued validity of data previously provided earlier by such organizations as the United Nations' International Telecommunications

Union (ITU) and NATO.

+++ Region 3 IARU Conference ends +++

Region 3 of the International Amateur Radio Union held its triennial conference in Christchurch, New Zealand October 12-16. Major actions taken by the delegates included affirming obtaining allocation of an

amateur 500 kHz band during WRC-12. The conference also firmly stated its dedication to strengthening its protection of amateur frequencies against intruders by strengthening the Region 3 Intruder Watch.

Ten member national societies sent delegates. Three more were represented by proxy. ARRL represents amateurs in US territories and possessions in the Region III. These include American Samoa (KH8) and Guam (KH2).

The conference accepted the invitation of the Vietnam ARC to hold its 15th Triennial Conference in Ho Chi Minh City in 2012.

+++ Hamfest Sponsors, You Own Part of the Agreement +++

ARRL is happy to sanction qualified hamfests as "ARRL Hamfests." The benefit to clubs and the hamfests they sponsor is free publicity in QST and on the ARRL web site. Free gift certificates usable to purchase ARRL publications are also given to use as prizes.

In return, hamfests that are sanctioned agree to a quid pro quo deal for ARRL. In return, ARRL hamfests agree to "... make space available for an ARRL display, and those ARRL hamfests which include formal speaking programs will schedule time for an ARRL meeting if so requested by the Director or another elected League official."

In my opinion, mutual courtesy between ARRL and the hamfest sponsors should include each one promoting the appearance of an ARRL official at a sanctioned hamfest when this appearance is known sufficiently in advance. This is precisely the reason behind the Travel Schedule published at the end of each of these issues of Words.

I hope that hamfest committees that do not plan formal speaking programs will still make time available for an ARRL Forum provided that space is available for it and the time is requested. Additionally, sanctioned hamfests "shall make every effort to use the ARRL diamond ... on the front of all advertising and program materials."

Obviously, a sanctioned hamfest can promote itself as being an ARRL Hamfest. This is encouraged, in fact.

+++ Canadian Mobiles must become Hands Free +++

According to an alert from the Radio Amateurs of Canada (the Canadian National organization), a new law in the Province of Ontario requires all two-way radios in nearly all vehicles on Canadian roadways to be hands free. The requirement applies to all commercial, CB and amateur equipment. The only exception to the rule is gear in emergency response vehicles.

We can only assume at this time that the law applies to vehicles operated by visitors from the US as well as Canadian amateurs. The new law became effective October 26. Tickets for infractions will begin to be issued effective February 1.

SWEEPSTAKES CHANGES

Changes for the 2009 November Sweepstakes



Next month, amateurs throughout the US and Canada will take part in the longest-running domestic contest, the 76th [ARRL November Sweepstakes](#).

Since 1930, this tradition in Amateur Radio has brought

out all kinds of amateurs — from seasoned contest veterans to neophytes, from long-time traffic handlers to operators new to HF. The CW running of Sweepstakes takes place next weekend, November 7-9, while the SSB weekend is November 21-23. Each event runs from 2100 UTC Saturday until 0300 UTC Monday. All entrants may operate 24 out of the 30 hours.

According to ARRL Contest Branch Manager Sean Kutzko, KX9X, there are some big changes with the

2009 ARRL Sweepstakes, specifically with log submission deadlines and the turnaround time for final results. “The contesting community has long asked for a faster turnaround with the contest results,” he said.

“This year, we will aim for having the results online on the ARRL Web site in a PDF only 60 days after each edition of Sweepstakes. This PDF will only be the scores; the detailed report and analysis will still be in the May and June issues of *QST*, as always.”

To make this faster turnaround possible, logs must be received at ARRL HQ within **15** days of the end of the contest, not 30 days, as it has been for years. Log submission deadlines are **0300 UTC Tuesday, November 24 for CW and 0300 UTC Tuesday, December 8 for Phone**. Kutzko said that the preferred method of log submission is the Cabrillo electronic format.

“We have several links on the [ARRL Contest Branch Web page](#) devoted to Sweepstakes tutorials, including how Cabrillo works and even templates for submitting an entry,” Kutzko explained. “While the ARRL will never turn away a paper log, we are asking all entrants to submit their log electronically if possible; this will greatly help us to publish the scores in 60 days as many participants have requested. Contest clubs are encouraged to assist their club members with paper logs in the Cabrillo conversion process. The [WA7BNM Cabrillo Web Forms site](#) will walk you through creating a Cabrillo-formatted log.

Numerous certificates and plaques will be awarded, thanks to [ICOM America](#), the principal awards sponsor of the November Sweepstakes. Special participation pins and Clean Sweep mugs will be available for purchase as always. Pins are available for \$6 to any station that submits a log with more than 100 QSOs. Clean Sweep mugs will be available to any station that submits a log with all 80 Sections worked; mugs cost \$12.

“Sweepstakes has been a part of Amateur Radio for nearly eight decades,” Kutzko said. “Don’t sit this one out. Check the ARRL Contest Branch Web site for your Sweepstakes ‘how-to’ package, get on the air, have fun and take part of one of Amateur Radio’s finest traditions — CQ SS!
