.. Pro Football Hall of Fame Festival Summary..

The week of August 1 – 7 was a busy one for many amateurs here in Stark County as we provided communications assistance for several events at the Pro Football Hall of Fame Festival. The Community Parade, Balloon Fest and finally the Hoover Grand Parade all benefited from amateur radio assistance.

Complete details of all the events are currently posted on the Stark County ARES website at www.wd8aye.org. A special thank you goes out to the Massillon ARC. Of the 43 total volunteers used during Festival Week, 17 were MARC members. That's forty-two percent participation, very well done club members. The club also provided the use of our Emergency Communications Trailer for the Community Parade which served as communications center during the event. Emergency Coordinator Dave Beltz appreciated all the help from our club.

.. Club Purchases Pneumatic Mast ..

The club gave approval at last months meeting to purchase a used pneumatic mast for installation in EComm 1, the clubs Emergency Communications Trailer. The mast was purchased from an area ham and came with numerous extra accessories. The mast was originally manufactured by the Will-Burt Company in Orrville and is in excellent condition. It is approximately 10 years old according to the serial number. The deal also included several accessories that would normally cost a great deal extra including the circular Ny-Coil which carries the cabling to the antennas, an air compressor with tank, a rotator and various connector plates used for installation. All in all it was a very good deal. We are currently working with Will-Burt to acquire some extra installation parts and mast lubricant before installation in the trailer. We hope to have the installation done in time to show it off at the hamfest.

Why did we want this mast when we already have the "Launcher" on the front hitch? Lets use Field Day as an example. The front mounted crank-up has been used to hold the Tri-Band antenna each year and it works well for this purpose. There are two drawbacks we face every year at this time. One is the number of helpers it takes to get it up in the air. At least 6 to 8 people are needed to raise it up with antenna's mounted. This is a guyed mast which means it take

a big footprint in order to accommodate the 12 guy ropes to keep it secure. This means a circle of about 50 feet in diameter to pound in the guy stakes. Fortunately the Field Day site is mostly grass which makes this possible.

What if we needed to raise the antenna in a crowded street or parking lot? No place for the guy ropes or soft grass to pound in stakes. In an emergency we have to depend on the roof mounted antennas. This is OK unless we need greater range or wanted to setup for low band operation.

It is for this reason and several others that we have been looking for a self supporting pneumatic mast for some time now. It will be a terrific addition to the trailer and allow us to raise up to about 100 pounds nearly 60 feet in the air within minutes with only a single person at the controls. Additional details will be available at the meeting.

FCC Emergency Communications Declaration Policy Prefers VHF-UHF

NEWINGTON, CT, Aug 13, 2004--The FCC has formalized its policy for issuing an emergency communications declaration (ECD) on Amateur Radio Service frequencies. The policy, which became effective August 2, states that ECDs will be issued for VHF or UHF repeaters--if the licensee consents--or on simplex channels in the 60-meter band. The FCC will not entertain requests to specifically sequester frequencies in other HF bands for emergency traffic only. Past emergency communications declarations--typically issued during weather-related emergencies--have put frequencies on 75 and 40 meters off limits to general use in an affected region. The practice has drawn complaints from members of the amateur community--especially from those well outside the affected region--and from emergency nets, which still experienced QRM.

"ECDs may only be issued after a disaster disrupts normal communication systems in a geographic area subject to FCC regulation," the FCC said, citing §97.401(b). Under its provisions, when a disaster disrupts normal telecommunications systems in a given area, the FCC may declare a temporary communication emergency that sets forth any special conditions and special rules stations must observe while it's in ef

fect. The policy clarifies that the FCC has authority to issue ECDs only for communication emergencies and not on the basis of anticipated emergencies.

The policy calls for VHF and UHF Amateur Service channels to receive preference for ECDs. Requests may indicate a specific repeater system, subject to permission from the repeater's licensee or trustee. On HF, the FCC says, an ECD may authorize the use of one or two 60-meter channels, which center on 5332, 5348, 5368, 5373 and 5405 kHz. "Use of these channels is subject to the requirements of §97.303(s)," the FCC said. One potential downside of the policy is the 50 W effective radiated power restriction on that band (see ARRL's Frequently Asked Questions regarding operation on 60 meters).

The FCC said frequencies in other Amateur Service bands--where emergency nets already have been established--may be used during emergencies under the provisions of §97.101(c). That rule section stipulates that Amateur Service control operators give priority to stations providing emergency communications "at all times and on all frequencies."

In announcing its policy, the FCC noted that amateurs have occasionally requested an ECD before an event, such as a hurricane or tropical storm, has occurred. "However," the Commission's policy points out, "transmissions prior to a disaster are already authorized by §97.401(a) and not subject to an ECD." Under §97.401(a), amateur stations may make transmissions "necessary to meet essential communication needs and facilitate relief actions" when normal telecommunication systems are overloaded, damaged or disrupted because a disaster has occurred or is likely to occur in an area where the Amateur Service is regulated by the FCC.

The FCC also has tightened up the requirements to request an ECD. Requests may come from an emergency management official responsible for emergency operations in the affected area and acting in an official capacity or from an Amateur Radio operator at the request of an emergency management official responsible for emergency operations in the affected area and acting in an official capacity. Among other information, requests must include the nature of the disaster, a description of the compromised telecommunication systems, the geographic area affected and the estimated length of time that normal telecommunication systems will remain out of service.

ARLB010 FCC to Stop Accepting Pre-December 2003 Form 605

Effective with Monday, May 3, receipts, the FCC's Wireless Telecommunications Bureau will dismiss any applications filed on an FCC Form 605 issued earlier than December 2003. Form 605, Quick-Form Application for Authorization in the Ship, Aircraft, Amateur, Restricted and Commercial Operator, and General Mobile Radio Service, is the hard-copy version of the Amateur Service application. The change does not affect applicants filing on-line with the Universal Licensing System (ULS) at, <http://wireless.fcc.gov/uls/>, said the FCC, which is encouraging on-line filing

ARRL VEC Manager Bart Jahnke, W9JJ, says the Form 605 announcement will affect the way ARRL has been making FCC Form 605 available. He says the League's widely distributed March 2001 Form 605 in a three-sheet ivory/buff-colored package with perforated pages will become obsolete for applications the FCC receives on or after May 3.

In the wake of the FCC's unexpected announcement, the ARRL is developing a replacement package that could require several more pages. It hopes to have it ready in time for Hamvention May 14-16.

The FCC has been accepting both older and current Form 605 applications that included a line (Item 9a) for a Taxpayer Identification Number, a Social Security number for an individual. The FCC would then issue the applicant an FCC Registration Number (FRN) without additional paperwork. All amateur applicants must have and use an FRN when filing an application such as Form 605 with the FCC. Applicants attending VEC test sessions can still supply a Social Security number, which will result in automatic Commission Registration System (CORES) registration.

All amateur applicants must have and use an FRN when filing an application such as Form 605 with the FCC. Under the system going into effect in May, applicants not yet registered in CORES and filing on paper will need to file FCC Form 160, CORES Registration to obtain a FCC Registration Number (FRN). After the FCC has issued an FRN, applicants also might want to file FCC Form 606 to associate the FRN with an individual's license record(s) and call sign(s). CORES registration data and FCC license data are maintained in separate FCC databases.

The completed Form 160 goes to a unique Washington, DC, FCC address to obtain the applicant's FRN. Once the FCC issues an FRN to the applicant, this number must be used when filing FCC Form 605, which

goes to the FCC's Gettysburg, Pennsylvania, office. The two forms may not be mailed to Gettysburg together. Applicants need to have obtained an FRN via Form 160 before they can file a Form 605.

ARRL recommends that all amateurs file an on-line or paper Form 606 to associate their FRN with their license record(s) and call sign(s) in the FCC license database. Jahnke says the easiest way is to do this electronically via the ULS, and the process now is fairly straight forward.

NEWS ITEMS OF INTEREST

Former Telegraphers to Gather at Steam Railroad Institute, Owosso, Michigan

On **Saturday, October 16, 2004** telegraphers from throughout the United States and Canada will gather both in person as well as on-line via a nationwide telegraph circuit to formally dedicate the Steam Railroad Institutes newly constructed telegraph office and a national telegraph hub. The gathering will also recognize the contributions of the late John AceHolman through whose efforts much of the necessary historical equipment was preserved. This event will provide a rare glimpse into an earlier era as numerous telegraph operators will be on the wire exchanging telegrams and conversing in American Morse Code.

These proceedings will be retransmitted on 14,050 kHz (+/- 3 khz) between approximately 11-AM and 3-PM, EST (1600Z to 2000Z) by K8QMN, thereby providing radio amateurs throughout North America with a rare

opportunity to hear the American Morse Code being used by experienced telegraphers. This code, developed by Morse and Vail is the predecessor to the International Code currently utilized by radio amateurs. It was utilized exclusively by US and Canadian landlinetelegraph services until the 1980s.

The national telegraph hub, recently installed at the Institute, permits telegraph offices throughout North America to be linked together via the public switched telephone network, thereby replacing the former iron and copper telegraph cables that once extended into every town and village in the US and Canada. Utilizing this device, multiple telegraphers can communicate in round tablefashion in much the same manner as one might communicate in an Internet Chat room.

The hub system was designed and built by members of the Morse Telegraph Club, an association founded by former professional telegraphers to educate the public about the important role the telegraph industry played in the development of transportation, industry, commerce, government, and the media. Both former operators and the public are encouraged to attend this unique historical event.

Glenn Keller, a distant relative, was told that Paul's keyer, microphone, antenna tuner and power supply were OK, but that the Paragon transceiver, which was a very early model, had serious problems and needed repair. I had been one that did repairs to Paul's gear over many years, and had also worked on his Paragon a few years ago and had planned to work on it again, but Paul passed on prior to the work.

Glenn wanted to know what to expect from any sale and was given "hamfest" prices based on good working equipment. He asked about donating it to the Radio club and was told that Paul was a Life Member since 1957.

Nothing more was heard, but upon visiting Ebay a few days ago, there it was..... offered as a complete lot by someone in Louisville, and listed as being in perfect working order. The seller was Emailed and informed that the transceiver was not in good working order and needed repair.

The seller was the Activities Director at Hospitality House, the nursing home where Paul lived. To her credit, she immediately corrected the listing to reflect the true status of the transceiver during the last 24 hours of the auction.

The entire assembly sold for \$561, probably a little over it's value considering the repair costs if sent to TenTec, but at least the buyer knew what they were getting. For a good working transceiver, the total cost might have been upwards of \$850 or more.

The proceeds go to the Activity Department Fund at Hospitality

House (owned by Steve, W8SEC, a club member) and we think that this was a good and proper decision by the executor. May the remaining residents benefit in some small way from their former neighbor.

The Paul Keller, K8EJN story, and a chapter in MARC history, is now closed.....
